On behalf of the Officers, Directors and Members of the Newport Yacht Club – Stoney Creek, beginning August 16th 2020 we would like to extend an invitation of reciprocal privileges to your members in the 2020 boating season.

Visitors are to reserve in advance prior to arriving at Newport Yacht Club. Please email our On-Water Director at onwater@newport-ycsc.com to request your preferred visitation dates. Requests are to be sent in advance no later than 48 hours prior to arrival. As well, any dock fees are to be paid in advance by e-transfer to treasurer.newportyc@gmail.com. You may also pay by credit card on our secure portal on our website. Please add 3% if paying by credit card. Once we have received your request and payment, we will advise you of your slip assignment.

COVID-19 PROTOCOL

AROUND THE CLUB:

- If you are sick...please stay home! Please do not come to the club if you are feeling ill or if you have been exposed to someone with Covid-19
- Social distancing must be maintained at all times around the club – maintain 2 meters or 6.5' from others at the marina
- Per City bylaws, masks are mandatory within our washrooms and clubhouse. We also recommend them around the club facilities where safe distancing cannot be maintained.
- Please move on to a finger or ramp when encountering other members or visitors when walking around the docks
- Only persons within your social bubble are allowed on your boat at this time
- Gatherings are not permitted on the docks. Guests should not be visiting member boats while moored at our club.
- Washroom facilities are now available however we continue to ask guests to use their on board facilities as much as possible.
- Visitors are to call our Harbormaster just before arrival. Phone: 905-662-9922 Ext 2.
- Visiting boats from other clubs must phone ahead two days before by contacting the harbour master he will assign a dock to you.(look up reciprocal policy)
- BBQ's shall not be utilized until further notice.
- Boaters are to use onboard cooking facilities until further notice

Details about the approach to Newport can be found in the Lake Ontario Ports Cruising Guide. We keep our channel dredged to a minimum of 6 ft. and we have a fully protected harbor with direct lake access. All docks offer 30 Amp shore power and potable water.

We have a small but very cozy clubhouse recently renovated, all set in a friendly residential community. Our facilities include washrooms with showers, laundry facilities, large covered deck, barbecues, picnic tables, ice, pump-out and pay phone. Several good restaurants are within walking distance. In an adjoining park, there is a children's playground, tennis courts and a baseball diamond.

Our policy at Newport is to offer free docking for two nights for visiting boats of Reciprocal Clubs, with proof of current membership & insurance. Additional days mooring are offered at the rate of \$1.50 per foot per day for up to three additional days. We can normally accommodate boats up to 40' – longer with advance notice.

Members of reciprocal clubs are asked, upon arrival to identify themselves to the Harbourmaster

ACKNOWLEDGMENT AND WAIVER VISITING BOATERS

(the "Visitor") ACKNOWLEDGES that despite the steps and precautions taken by Newport Yacht Club Stoney Creek (NYCSC) and its Board of Directors, the use of NYCSC's facilities entails some unavoidable risk, given the nature of COVID-19.

In consideration of and for the opportunity to use the Club's Facilities, the Visitor:

1. ASSUMES those risks, including the risk of exposure to the novel corona virus that causes the disease or condition commonly referred to as COVID-19, and the risk of contracting COVID-19 ("COVID-19 Risks").
2. AGREES to abide by all rules, policies, and procedures NYCSC have implemented, or may in the future implement to reduce COVID-19 Risks (all "COVID-19 Measures").
3. ACKNOWLEDGES that a failure to comply with any COVID-19 Measures may result in the Visitor being denied access to the Club's Facilities.
4. AGREES AND UNDERTAKES not to bring any claims for injury, loss, or damages against NYCSC, their directors, staff, principals or related entities (NYSC parties) including without limitation any claims arising out of or relating to, without limitation, exposure to the novel corona virus and/or contracting COVID-19 (any "Claims"), and THE VISITOR HEREBY RELEASES, AND FOREVER DISCHARGES the NYCSC Parties from and against any and all Claims arising out of or relating to, without limitation, the COVID-19 risks, including novel corona virus and/or contracting COVID-19.
5. AGREES AND UNDERTAKES to refrain from travelling on any NYCSC Vessels or entering the Club's Facilities while exhibiting any COVID-19 symptoms, during any period during which the Visitor should or must be in quarantine or self-isolating based on orders, and/or guidance provided by government or public health officials, or while knowingly infected with the novel corona virus and/or COVID-19.
6. AGREES AND ACKNOWLEDGES having had the opportunity to obtain independent legal advice before signing this document.
